GreekKeys Keyboards/Inputs License

This license applies both to GreekKeys Mac keyboards in the .rsrc format and to GreekKeys Mac Unicode inputs in the XML format with suffix .keylayout and to these same files when embedded in the collections GKUall.bundle, GKUdcmp1.bundle, GKUdcmp2.bundle, and GKTraditional.bundle, and to Windows GreekKeys Unicode keyboards introduced in 2008.

NOTE: In the following, the numbers expressing limits refer to the permitted number of separate computers or CPUs and not to the number of instances of the software. For instance, a single Mac Intel computer with three partitions or volumes could have two instances of the Mac software installed on two separate Mac OS volumes and one instance of the Windows software installed on a Windows volume and still count as one computer for the purposes of these licenses.

(1) Individual License

The American Philological Association licenses this software for use by the individual purchaser on up to three computers used primarily by the purchaser as an individual (e.g., desktop computer in office, desktop computer in home, and laptop).

(2) Small Department License

The American Philological Association licenses this software for use by a small department. ## APA Fonts License

This license applies to copyrighted fonts distributed by the American Philological Association. It covers both fonts encoded in the custom GreekKeys encoding developed with the original GreekKeys packages and fonts encoded with Unicode, regardless of font format (PostScript, TrueType, OpenType) and file suffix. The basic names of the fonts covered are (GreekKeys-encoded) Athenian, Attica, Classical, SymbolAthenian, Bosporos, Kadmos, and (Unicode) New Athena Unicode (with its superseded predecessor Athena Unicode), AttikaU, BosporosU, and KadmosU.

**The TrueType version of Athenian font and the TrueType version of New Athena Unicode font are made available to all as freeware to facilitate communication on the internet. They may be used in digital or print publication without further permission from the APA. They may not be altered or redistributed without permission.**

The APA fonts other than Athenian and New Athena Unicode are not freeware. From time to time versions of them may be available to academic users for free downloading during testing and development.

License for the fonts is granted as part of the purchase of the GreekKeys software package and may be granted as a separate purchase.
